Originally developed to treat adults with substance abuse issues, Motivational Interviewing (MI) has evolved into a counseling approach that applies to multiple fields. MI emphasizes empathetic listening and techniques to empower client self-determination and positive action. In this two session, 11-hour training, participants will learn the foundations of Motivational Interviewing (MI) and practice MI techniques. See the course outline here.
